LEARNING MODELS YOUR CHOICE - FROM DAY ONE!

33% of LJA households include someone at greater risk for COVID-19 due to underlying medical conditions 55% of families said they'd prefer a distance learning option if there was sustained spread of COVID-19 in Hawai'i.

Option 2: Distance Learning (DL)

ENHANCED LEARNING AND TECHNOLOGY

Blended learning tools already augment face-to-face learning across all grade levels--from younger students reflecting on learning via pictures and video to older students working on collaborative documents and presentations. Additionally, LJA has added the following enhancements to support learning for the new school year:



- Students in grades PK-2 now have one-to-one iPads (one-to-one devices for PK-5)
- Additional video conferencing technology in classrooms to improve inclusion of distance learning students
- > K-5 team teaching approach for enhanced flexibility and excellence in each subject
- > Daily advisory for high school students
- Subject-specific support for secondary students
- ➤ More outdoor instruction

HEALTH AND SAFETY PRACTICES

The following practices have been adopted and are presently in effect on campus during our Summer Programs. These practices may be updated to meet current public health conditions prior to the start of school.



Daily Self Screenings	All students and staff must complete a daily self-screening form, including a temperature check, symptom check, and questionnaire assessing one's likelihood of coming in contact with COVID-19, online and prior to arrival on campus.
Physical Distancing	Enhanced physical distancing protocols have been implemented for all classroom, outdoor, and transition activities. Protocols may vary by LJA Risk Response Level and according to the unique needs of each division and activity.
Masking	Students and staff must wear face masks to school each day. Masks will generally be worn in the classroom and common spaces on campus where physical distancing cannot be maintained. Procedures may vary by division.
Handwashing hygiene	Students and staff will practice frequent and effective handwashing with soap and water as our primary means of hygiene. Specific practices and hand washing schedules may vary across divisions.
Sick Child Protocols	Sick children must be kept home, and may return to school after 72 hours with no symptoms. Protocols for sick students and faculty are in place, as is a COVID Response Plan the event of a COVID-19 case on campus.
Visitors to Campus	For the safety of our students, visitors to campus are restricted. Pre-approved visitors must complete a self-screening form prior to arrival on campus.
Cleaning and Disinfecting	Enhanced procedures for for classrooms, offices, and high touch areas have been deployed.
Travel	LJA complies with Federal and State travel guidelines. Travel related to field trips may vary by Response Level.

CAMPUS ENHANCEMENTS

We are deeply invested in ensuring the health and safety of our students, faculty, and staff, and have our Blue Crew and contracted vendors working tirelessly to keep our campus clean and inviting for our students. Important enhancements have been added to support a healthy learning environment for the new school year, including:

- > New tents, awnings, and flexible furniture to support more outdoor learning
- > New filters in all air conditioning units
- New portable hand washing stations throughout campus
- > Bipolar ionization strips in classrooms to disinfect air particles
- > Blower fans in classrooms to increase and redirect air flow
- > Enhanced disinfection procedures for classrooms, offices, and high touch areas
- New electrostatic sprayers for daily cleaning
- Additional nursing staff coverage

A: LJA's health and safety protocols for a phased return to campus have been informed and approved by DHS, DOH, and the LJA Medical Hui. Detailed models specific to each division's needs have been crafted to mitigate the spread of illness on campus, and protocols for a COVID-19 occurrence	A: Should a case occur, LJA will activate its COVID-19 response plan. An all-school communication will be issued to notify families. Procedures are in place to aid those individuals directly impacted and to ensure proper disinfection of affected areas of campus.	A: Whether face-to-face or in distance learning, students will receive the same rigorous and engaging IB curriculum with the understanding that the learning experiences and how students' engage with them may look different between the two models.	A: LJA's Risk Response Level can be found at any time on its website and in the LJA Weekly, and all-school announcements about health and safety in our community will be made regularly.	A: Families can opt one or more children from the same household into Distance learning each Quarter, if the school elevates to an increased risk level, or in the event of required quarantine. We ask that in the event of a level 2, DL students remain in DL until the situation improves.
